In addition to the cars, all the furniture is staying with the house, including a vintage pool table, 1890 piano and crystal chandeliers.

POOL HOUSE An 8-foot-deep indoor pool is the focal point of a Hewlett Bay Park home on the market for \$1.55 million.

The pool is in the center of the house on the first floor, and all of the rooms sit in a horseshoe shape around it. Glass walls allow for the pool to be appreciated from
